## SECTION II - INSTRUCTIONS TO APPLICANTS

### 1.1 Scope of Tender

- 1.1.1 Bomet County Assembly intends to prequalify suppliers for supply and delivery of goods/services detailed in the invitation for prequalification.
- 1.1.2 **Prequalification is open to only persons/companies who have capacity to enter into contract and registered under the Laws of Kenya** to supply or provide respective merchandise/services/works so that they can be pre-qualified for submission of quotations/tenders.
- 1.1.3 This document includes questionnaire forms and documents required of prospective suppliers
- 1.1.4 The main objective is to supply and deliver assorted items and also provide services under relevant tenders/quotation to the **Bomet County Assembly** 'as and when required' basis during Financial Years 2017/18-2018/19

### 2.1. Submission of Application

- 2.1.1 Applications for prequalification shall be submitted in plain sealed envelopes marked with the prequalification reference number and description and deposited in the tender box at the following address or posted to:

- 2.1.2 All the information requested for pre-qualification shall be provided in English.
- 2.1.3 Failure to provide information that is essential for effective evaluation of the applicant's qualification or to provide timely clarification will lead to automatic disqualification.

### 3.1 Eligible Applicants

- 3.1.1 This Invitation for Bids is open only to companies or special groups and registered under the laws of Kenya except as provided hereinafter;
- 3.1.2 Bidders must not be under a declaration of suspension for corrupt, fraudulent, collusive, coercive or obstructive practices as issued by the Kenya government.

#### **4.1 Qualification Criteria**

- 4.1.1 Pre-qualification will be based on meeting the minimum requirements to pass in the criteria for the various categories as set out in the Appendix 1 hereof. A short listing of suppliers will also be done taking into account the applicant's general and particular experience, personnel, physical location, capability and financial position as demonstrated by the applicant's response in the attached forms.
- 4.1.2 The applicant should provide accurate information on any litigation or arbitration resulting from contracts completed or under its execution over the last five years.
- 4.1.3 Suppliers who qualify according to the selection criteria will be invited to submit their quotations for the supply of goods/services as and when required depending on continuous performance.
- 4.1.4 The applicant should show proof of capacity to supply
