### **PETITIONS**

PETITION FOR ESTABLISHMENT OF A DISPENSARY AT KAPKOITIM WITHIN KAPLETUNDO

**Hon. Speaker (Hon. C. Korir):** I do not know whether the Petitioners are there. Serjeant-at-Arms, if the Petitioners from Kapkoitim, Kapletundo Ward are present, kindly usher them to the public gallery.

Hon. Speaker (Hon. C. Korir): Thank you very much. There is a petition to the County Assembly of Bomet for the establishment of a dispensary at Kapkoitim within Kapletundo Ward. It reads, 'We the undersigned citizens of the Republic of Kenya and residents of Kapkoitim in Kapletundo Ward within Bomet County draw the attention of the County Assembly of Bomet to the following:

That the constitution of Kenya guarantees every Kenyan citizen and any other such person in Kenya the highest attainable standards of healthcare which includes the right to healthcare services including reproductive healthcare.

Two, that one of the frameworks to attaining the highest standards of this constitutional right is the formulation of the Kenya Health Policy 2014, 2013 that strives for significant improvement in the overall status of health in Kenya in line with the Vision 2030 and global commitments.

Three, that the said policy demonstrates the health sector's commitment under the government's stewardship to ensure that the country attains the highest possible standards of health in a manner responsive to the needs of the population in Kenya.

Four, that the constitution of Kenya devolves and vested the responsibility of various in functions to the county government which are the earlier, provision of Health services which includes the county health facilities and pharmacies.

Five that the full employment, full enjoyment of the right to health revolves around availability, accessibility, acceptability and quality; all leading towards achieving a universal health coverage and sustainable development goal by 2030.

That therefore, the right to healthcare should not only be available in our county but also accessible geographically and it should be accessible to those who use it.

That the dispensaries are at the lowest level of Public Health System and are the first point of contact for patients.

That the residents of Kapkoitim have since time immemorial been discriminated against in

terms of the availability and acceptability of health services.

That the area lies within Kapletundo Ward in Kamungei location and according to the 2019 Kenya Population and Housing Census report, Kapkoitim Sub location has a total of 2,901 persons with 556 households with an area of 4.6 Square Kilometres and a density of 627 persons Per Square Kilometre.

That this heavily populated area does not have a single Healthcare facility.

That the residents are forced to seek healthcare services from a neighbouring dispensary in Kapletundo location which has a population of 9,183 persons and is served by a single facility. That the said facility is situated on a 50x100 parcel of land which also hosts a Police Post, a ward administration office, and a chief's office.

That the patient's right to treatment while respecting their dignity rights and choice among others has been infringed by the county government by denying free accessibility and acceptability to the context of the patient's right.

That Kapkoitim Sub location neighbours Chesilyot, Kesengei, Ririk and Chemobei whose areas do not have a single health facility hence forced to seek medical attention at Kapkatet Sub County Hospital in Kericho County.

That the Ministry of Health in it's Kenya Health Policy 2014, 2013 changed its cost-sharing policy and replaced it with a 10/20 policy in which dispensaries and health centres are not to charge users fees of curative care other than Ksh 10 or Ksh 20 for client's cards.

That these residents by traversing to a level four facility in another county incur certain costs and an additional registration fees against their rights to affordable health healthcare care for all.

That some health services including antenatal care and treatment for simple medical treatment but the residents are forced to travel and incur unnecessary costs at the level four facility for the said services in a different county.

That since the inception of devolved governments the residents have time and again in various Public Participation forums, voiced their requests including ensuring that it is incorporated into the county-integrated development plans of 2013 - 2017, 2017 - 2022 and now 2023 - 2027 and the current annual developments of 2023 - 2024.

That we are forced to have this matter addressed by the relevant authorities all of which have failed to give satisfactory response thus the petition to the County Assembly which is vested with the power to represent the residents of Bomet County and particularly the residents of Kapkoitim in respect of this subject matter.

That none of these issues raised in this petition is pending in any court of law, any constitutional or any other quasi-judicial organs.
