6. MOTION (Hon. Charles Langat)

THAT, aware that one of the functions devolved under part 2 of the fourth schedule of the Constitution of Kenya 2010 is that of county transport including county roads; also aware that section 112 of the Public Finance Management Act,2012 provides that the County Executive Committee for finance may make payments from the County Emergency Fund for urgent and unforeseen expenditures; further aware that section 23 of the Bomet County Disaster and Emergency Act, 2014 provides for instances when the County Disaster Management Fund shall be used; also aware that quite a number of roads within the county have been greatly affected by the ongoing heavy rains and are now in dilapidated conditions; deeply concerned that unless urgent interventions are undertaken the entire road network might get disconnected and hamper transportation of people and goods within the county thus occasioning serious economic loses; this County Assembly urges the County Executive to urgently repair damaged roads within the county.
